S-34 (1808) DETERMINATION AND EXTENSION OF CONTRACT TIME – **Remove and Replace** Paragraph S-34.2 with S-34.2: Contractor must complete all Work to meet the requirements of MnDOT 1516.2, “Project Acceptance,” under this Contract before July 10, 2021.

S-34 (1808) DETERMINATION AND EXTENSION OF CONTRACT TIME – **Remove and Replace** Paragraph S-34.4 with S-34.4: The following language is deleted from MnDOT 1806.3: "(3) During the inclusive period from November 15 through April 15, except as specified in 1806.1, “Determination and Extension of Contract Time, General.””.

S-34 (1808) DETERMINATION AND EXTENSION OF CONTRACT TIME – **Remove and Replace** Paragraph S-34.5 with S-34.5: The Department based Contract Time (Completion Date) on an anticipated six day work week, Monday through Saturday.
