(I) (We) understand that the quantities of work shown herein are approximate only and are subject to increase or decrease; that the quantities of work listed in the separately identified alternate bids may or may not be awarded; that all quantities of work, whether increased or decreased within the limits specified in 1903 of the Mn/DOT Standard Specifications, are to be performed at the unit prices or lump sums as shown on the attached schedule; and that, at the time of opening of bids, totals only will be read.

(I) (We) propose to furnish all necessary machinery, equipment, tools, labor, and other means of construction and to furnish all materials specified, in the manner and at the time prescribed, all in accordance with the terms of the Contract and the Plans, Specifications, and Special Provisions forming a part thereof.

(I) (We) further propose to do all Extra Work which may be required to complete the contemplated improvement, at unit prices or lump sums to be agreed upon in writing prior to starting such work, or if such prices or sums cannot be agreed upon, to perform such work on a "Force Account" basis, all as provided in 1904 of the Mn/DOT Standard Specifications and S-44 in the Special Provisions.

(I) (We) further propose to furnish a Payment Bond and a Performance Bond, each in the amount of the Contract as security for the construction and completion of the improvement in accordance with the Plans, Specifications, and Special Provisions as provided in 1305 of the Mn/DOT Standard Specifications and S-15 in the Special Provisions.

(I) (We) further propose to execute the form of Contract within five (5) days after receiving written notice of award, as provided in 1306 of the Mn/DOT Standard Specifications and S-16 in the Special Provisions.

(I) (We) further propose to perform all work in accordance with the Plans, Specifications, and Special Provisions and in a good workmanlike manner; and to renew or repair any work which may be rejected due to defective materials or workmanship, prior to final completion and acceptance of the project by the Hennepin County Engineer or by his authorized representative.

(I) (We) further propose to begin work and to prosecute and complete the same in accordance with the time schedule set forth in the Special Provisions for the improvement.




